



## **Information for Authors**

*The Australian and New Zealand Continence Journal* welcomes original research articles for peer review and general articles regarding the achievements of people working in the disciplines pertaining to the management of incontinence, clinical issue updates, book reviews and general project information.

### **Peer review**

The journal invites original papers and manuscripts relating to the promotion, treatment or understanding of incontinence from medical practitioners, nurses and allied health professionals including pharmacists, physiotherapists and occupational therapists. Further information on the presentation of manuscripts is available at [www.icmje.org](http://www.icmje.org).

Recommended word length for manuscripts and papers for peer review is 1500 - 3000 words (note that word count includes references).

These papers will be subject to a blind review by two experts in the field. It may take up to eight weeks for the review process to be complete.

### *Submitting manuscripts and research papers for peer review*

All articles submitted to the journal for peer review must be set out as follows: a title page, an abstract and key words, methodology, results, discussion, conclusion, tables and figures.

### **Tables and figures**

Each table and figure must be presented on a separate page following the reference list. Tables and figures must be numbered in the order they appear in the text.

Figures that include line drawings such as graphs, flow charts and schematic diagrams should be computer generated or professionally drawn.

The manuscript should be emailed as a Word document set out in plain text with pages numbered and no identification of the author on any page.

### **References**

References follow the convention of the Vancouver system. All references are to be numbered within the text and listed at the end of the paper consecutively as they appear in the text.

## **Author Statement and Copyright**

An Author Statement and Copyright Release Form will be provided by the production editor once a paper has been accepted for publication. This form must be signed by all named authors. This is a statement that the author has contributed to the writing of the paper and that a paper or a paper of similar content has not been published elsewhere in any media. If using graphs or tables from another text the original source must be acknowledged within the manuscript and written permission from the copyright holder to reproduce the material must accompany the manuscript. ## **Author disclosure**

An Author Disclosure Statement form must accompany all manuscripts. This form is available on the website: [www.continence.org.au](http://www.continence.org.au). This statement relates to competing interests and pecuniary interests of authors and follows the guidelines of the ICMJE Uniform Requirements for Manuscripts.

## **Article style**

- *General news, personal profiles, book reviews, clinical issues and product information articles* should be 250 - 1000 words in length and submitted via email as a Word document typed in plain text and with minimal formatting. Articles including summaries from participants of workshops and meetings both national and international are welcome.
- *Letters to the editor* are welcome and should be 100 - 200 words and include the author's full name, address and daytime telephone number.
- *Photographs* of events and people working in the area of continence health promotion and clinical management are welcome and should be provided on CD. Please contact the production editor prior to sending photographs.

Assistance to authors is provided by the production editor. Authors are encouraged to contact the editor or the production editor to discuss contributions to the journal.
